

## ARMENIA

**Region:** Europe and Central Asia

**Income group:** Lower-middle income

**Summary:** Armenia has reported 4 metadata sources, which collect information on international labour migration statistics. There are three survey based sources such as *Population and Housing Census*, *Integrated Survey on Living Conditions of Households*, and *Comprehensive Survey on Migration of the Population of the Republic Armenia (RA)*, which are carried out by the National Statistical Service of the Republic of Armenia. There is an administrative record, such as *The Information System of Border Control RA* held by the National Security Service under the Government of the Republic Armenia (RA.)

Geographically all of the sources cover whole country, however different population groups such as:

- *Nationals (citizens) in the country (covered by the Population and Housing Census, the Integrated Survey on Living Conditions of Households, and the Comprehensive Survey on Migration of the Population of the RA),*
- *Nationals (citizens) employed in the country (covered by the Population and Housing Census, the Integrated Survey on Living Conditions of Households, and the Comprehensive Survey on Migration of the Population of the RA),*
- *Nationals (citizens) living abroad (covered by the Population and Housing Census, the Integrated Survey on Living Conditions of Households, and the Comprehensive Survey on Migration of the Population of the RA),*
- *Nationals (citizens) living and working abroad (covered by the Integrated Survey on Living Conditions of Households and the Comprehensive Survey on Migration of the Population of the RA),*
- *Foreigners (non-citizens) living in the country (covered by the Population and Housing Census and the Comprehensive Survey on Migration of the Population of the RA),*
- *Foreign workers (non-citizens) living in the country (covered by the Population and Housing Census and the Comprehensive Survey on Migration of the Population of the RA),*
- *Refugees (covered by Comprehensive Survey on Migration of the Population of the RA and the Information System of Border Control RA),*
- *Asylum seekers (covered by the Information System of Border Control RA),*
- *Child workers (non-citizens) in country (covered by the Integrated Survey on Living Conditions of Households and the Comprehensive Survey on Migration of the Population of the RA), and*
- *Foreigners (non-citizens) entering country for temporary purposes (covered by the Information System of Border Control RA).*

Periodicity of data collection varies depending on the type of sources. The *Population and Housing Census* in Armenia was last processed in 2011; the *Integrated Survey on Living Conditions of Households* is carried out continuously the last one was in January 2001; the *Comprehensive Survey on Migration of the Population of the RA* collects the data irregularly, the last one was in July 2013. The *Information System of Border Control RA* is carried out every month since 2011.

Except to the Border/Admission Statistics, where all ages are covered, surveys cover population groups aged 15-75 years old.

The five essential demographic characteristics covered by the surveys are age, gender, marital status, educational attainment, and household size. In the *Information System of Border Control RA*, the data on age and sex can be found. International migration characteristics collected in the surveys comprise of country of birth, country of citizenship, second country of citizenship, nationality, country of previous residence for foreigners, country of previous residence for citizens who lived abroad but returned, foreign workers, household members living abroad,

and remittances related characteristics. *Information System of Border Control RA* record generates the data on country of citizenship of persons examined.

Labour related characteristics such as employment status, occupation, industry/economic sector, status in employment, hours usually worked, individual earnings, and household income can be found in one of the surveys.

Definitions of “*international migrant workers*”, “*nationals living abroad*”, and “*overseas visitors*” are used in the sources. The definition of “*employment*” is fully consistent with the ILO recommendations.

To classify occupation and industry all the surveys apply nationally adapted classifications. To classify status in employment and education, the standard international classifications are used. Micro data files from the surveys are available for research and analysis free of charge.

#### Findings:

The latest *Population and Housing Census* in Armenia was carried out in 2011 by the National Statistical Service covering the country’s entire population. There are five population groups examined in the *Population and Housing Census*:

- *Nationals (citizens) in the country,*
- *Nationals (citizens) employed in the country,*
- *Nationals (citizens) living abroad,*
- *Foreigners (non-citizens) living in the country, even if arrived recently, and*
- *Foreign workers (non-citizens) living in the country.*

The *Population and Housing Census* obtains detailed data on demographic characteristics of these population groups. The questions raised in the assessment on the topic of international migration related characteristics, comprise of country of birth, country of citizenship, country of previous residence for foreigners, and country of previous residence for citizens who lived abroad but returned. Information on the members aged 15-75 who used to live in the household was collected, but only the members who were absent for not more than 12 months at the time of the census (12 October 2011) were included in the population of the RA. The following characteristic of these persons are compiled in the source:

- Name,
- Month/year of departure,
- Sex,
- Main reason for leaving,
- Age at present,
- Marital status at present,
- Education at present,
- Employment status at present, and
- Occupation at present.

In addition to demographic characteristics, the *Population and Housing Census* covers labour related characteristics of all current household members aged 15-75 years:

- Employment status,
- Occupation,
- Industry/economic sector, and
- Status in employment.

Information on remittances received from household members living abroad or sent to household members living abroad, and the total amount of remittances, is collected in the census. The *Population and Housing Census* contains questions, which help to collect information on immigrants and return migrants such as: ‘*Have you ever lived outside this country?*’ and ‘*When did you arrive to this country?*’ If the answer is yes, the census will cover the main reason for migration to this country.

“*International migrant workers*” are defines as foreigners aged 15-75 temporary residing in the RA and who were employed/self-employed/searching for a job from 4 to 11 October. “*Nationals living abroad*” are persons who permanently or for a long-term (12 months or more) resettled to another country. The definition of “*employment*” is fully consistent with the ILO recommendations. To classify occupation, industry, status in employment, and education in Armenia, nationally and internationally adapted classifications are used. For example:

- National adaptation of ISCO - 08 (where two digits are used to release the data);
- National adaptation of NACE rev 2 (where two digits are used to release the data);
- ICSE - 1993; and
- ISCED - 1997.

Micro-data files are available for research and analysis outside the National Statistical Service for free.

There are two *household surveys* in Armenia, in which statistics on international labour migration can be found, such as:

- *Integrated Survey on Living Conditions of Households and*
- *Comprehensive Survey on Migration of the Population of the RA.*

The *Integrated Survey on Living Conditions of Households* in Armenia is held continuously, the last one was in January 2001, by the National Statistical Service of the RA. A completed sample size of the examination is 5,184 households, which is 19,381 individuals of which 1,197 are emigrants and 490 are return migrants. It

geographically measures the whole country and amasses information on the following five population groups aged 15-75 years:

- *Nationals (citizens) in the country,*
- *Nationals (citizens) employed in the country,*
- *Nationals (citizens) living abroad,*
- *Nationals (citizens) living and working abroad, and*
- *Child workers (non-citizens) in the country.*

The ***Integrated Survey on Living Conditions of Households*** retrieves the data on demographic characteristics, of each person in a household. The questions raised in the assessment on the topic of international migration related characteristics, comprise of country of birth, household members living abroad, and remittances received/sent from/to someone living abroad. Information on the household members who left to live abroad in the last three years prior to survey year is collected. The following characteristics of these persons are covered:

- Name,
- Month/year of departure,
- Sex,
- Main reason for leaving,
- Age at present,
- Marital status at present,
- Education at present,
- Employment status at present.

For the population groups assessed in the survey, the data on labour related characteristics is available, particularly for:

- Employment status,
- Occupation,
- Industry/economic sector,
- Status in employment,
- Individual earnings per month,
- Household income, and
- Hours usually worked.

The household survey questionnaire includes questions on unemployment benefits received from employer and retirement pension. The ***Integrated Survey on Living Conditions of Households*** contains questions, which help to collect information on immigrants and return migrants such as: ‘*Have you ever lived outside this country?*’ and ‘*When did you arrive to this country?*’ If the answer is yes, the census will cover the employment status, industry/economic sector, and reason for leaving previous country of residence for immigrants and return migrants.

Definitions of “***international migrant workers***”, “***national living abroad***”, and “***employment***” used in the survey are the same as in the census. To classify occupation, industry, status in employment, and education in Armenia, internationally and nationally adapted classifications are applied. For example:

- National adaptation of ISCO - 08 (where one digit is used to release the data);
- National adaptation of NACE rev 2 (where two digits are used to release the data);
- ICSE - 1993; and
- ISCED – 1997.

Micro data are available for research and analysis for free.

The ***Comprehensive Survey on Migration of the Population of the RA*** is held irregularly, the last one was in July 2013, by the National Statistical Service. A completed sample size of the examination is 7,890 households, which is 31,118 individuals, of which 28,899 are emigrants, 829 are return migrants, and 129 are immigrants. It

geographically measures the whole country and amasses information on the following eight population groups aged 15 years and older:

- *Nationals (citizens) in the country,*
- *Nationals (citizens) employed in the country,*
- *Nationals (citizens) living abroad,*
- *Nationals (citizens) living and working abroad,*
- *Foreigners (non-citizens) living in the country, even if arrived recently,*
- *Foreign workers (non-citizens) living in the country,*
- *Refugees, and*
- *Child workers (non-citizens) in the country.*

The ***Integrated Survey on Living Conditions of Households*** retrieves the data on demographic characteristics, of each person in a household. The questions raised in the assessment on the topic of international migration related characteristics, comprise of country of birth, country of citizenship, second country of citizenship, country of previous residence for foreigners, country of previous residence for citizens who lived abroad but returned, nationality, foreign workers in the country, household members living abroad, and remittances related characteristics. Information on the household members who left to live abroad is obtained starting from those who left from 2007 until the survey start date. The following characteristics of these persons are compiled:

- Name,
- Month/year of departure,
- Sex,
- Main reason for leaving,
- Age at present,
- Marital status at present,
- Education at time of leaving,
- Education at present,
- Employment status at time of leaving,
- Employment status at present,
- Whether that person intends to return,
- Whether that person made own decision or other household members also took a decision.

For the population groups assessed in the survey, the data on labour related characteristics is available, particularly for:

- Employment status,
- Industry/economic sector,
- Status in employment,
- Individual earnings per month, and
- Hours usually worked.

The household survey questionnaire contains questions, which help to collect information on immigrants and return migrants such as: *'Have you ever lived outside this country?'* and *'When did you arrive to this country?'* If the answer is yes, the survey will cover the employment status, status in employment, industry/ economic sector, reason for migration to this country, and reason for leaving previous country of residence for immigrants and return migrants.

Definitions of ***"international migrant workers"***, ***"national living abroad"***, and ***"employment"*** used in the survey are the same as in the census. To classify industry, status in employment, and education in Armenia, internationally and nationally adapted classifications are applied. For example:

- Enlarged classification according to NACE (where one digit is used to release the data);
- ICSE - 1993; and
- ISCED – 1997.

Micro data are available for research and analysis for free.

**Border/Admission Statistics** are covered by the **Information System of Border Electronic Control RA** data obtained from the National Security Service under the Government of the RA. The data collection is carried out every month starting from 2011 by the agency. It processes the following four population groups of all age groups:

- *Foreigners (non-citizens) entering country for temporary purposes,*
- *Refugees, and*
- *Asylum seekers.*

The statistics cover demographic characteristics such as age and sex. The migration related topic covered is country of citizenship. **“Overseas visitors”** are persons who are not citizens of the RA and who have citizenship (based on official documents) in another country.
