Summary: Belgium has reported 5 metadata sources, which collect information on international labour migration statistics. There are four survey based sources such as the *Census 2011*, the *Labour Force Survey*, the *Household Budget Survey*, and the *Wage Structure Survey*, which are carried out by the Statistics Belgium. There is one administrative record of the *Data Warehouse of Labour Market and Social Protection* held by the Crossroads Bank for Social Security.

Geographically the sources cover whole country, except to the *Household Budget Survey*, which covers three regions of Brussels-Capital, Flanders, and Wallonia. The statistics on the following population groups are available:

- *Nationals (citizens) in the country (covered by the Census 2011, the Labour Force Survey, Household Budget Survey, and the Data Warehouse of Labour Market and Social Protection),*
- *Nationals (citizens) employed in the country (covered by the Census 2011, the Labour Force Survey, the Household Budget Survey, and the Data Warehouse of Labour Market and Social Protection),*
- *Nationals (citizens) living abroad (covered by the Data Warehouse of Labour Market and Social Protection),*
- *Nationals (citizens) living and working abroad (covered by the Data Warehouse of Labour Market and Social Protection),*
- *Foreigners (non-citizens) living in the country (covered by the Census 2011 and the Data Warehouse of Labour Market and Social Protection),*
- *Foreign workers (non-citizens) living in the country (covered by the Census 2011, the Labour Force Survey, the Household Budget Survey, and the Data Warehouse of Labour Market and Social Protection),*
- *Refugees (covered by the Census 2011),and*
- *Asylum seekers (covered by the Census 2011).*

Periodicity of data collection varies depending on the type of sources. The Census was last processed in 2011; the *Labour Force Survey* is carried out every three months starting from 1983; the *Household Budget Survey* is held every two years since 1999; the *Wage Structure Survey* is held annually starting from 1999; and the *Data Warehouse of Labour Market and Social Protection* is released at the request of the user starting from 1998.

Age coverage also varies depending on the type of sources. In the *Labour Force Survey* persons aged 15 years and older are examined. The *Household Budget Survey* and the *Data Warehouse of Labour Market and Social Protection* are applied to persons of all ages.

The three essential demographic characteristics covered by all the sources are age, sex, and educational attainment. Data on marital status and household size are added in the three household survey based sources.

International migration characteristic covered by all the sources is country of birth. The questions on country of citizenship and nationality are also very often asked in the surveys and administrative records. Other international migration statistics that can be found in the sources include information on immigrants and return migrants, remittances sent and remittances received by the household from someone living abroad, year of arrival, reason for coming to country, foreign workers in the country, country of origin, and country of previous residence.

Labour related characteristics are compiled in all the sources. The *Labour Force Survey* and the *Household Budget Survey* contain the biggest variety of questions related to labour characteristics, such as employment status, occupation, industry/economic sector, status in employment, household income, wage or earnings rate per time period, hours usually worked, whether person has had disability, and possible benefits received from the employer. Both the *Census 2011* and the *Data Warehouse of Labour Market and Social Protection* cover

employment status, industry/economic sector, and status in employment. The *Wage Structure Survey* asks questions on occupation, wage rate, and data of beginning to work for company.

Definitions of “*international migrant workers*”, “*nationals living abroad*”, “*employment*”, and “*wages*” are applied in the sources. Definition of “*employment*” used in the *Labour Force Survey* and the *Household Budget Survey* is the standard ILO definition.

To classify occupation, industry, status in employment, and education internationally adapted classifications are used in the sources.

Micro data files from the sources are available for research and analysis outside the agency at different costs.

Findings:

The latest Census in Belgium was processed in 2011 by the Statistics Belgium covering the whole country. There are six population groups examined in the Census:

- *Nationals (citizens) in the country,*
- *Nationals (citizens) employed in the country,*
- *Foreigners (non-citizens) living in the country,*
- *Foreign workers (non-citizens) living in the country,*
- *Refugees, and*
- *Asylum seekers.*

The Census obtains detailed data on demographic characteristics of these population groups, such as:

- Age,
- Sex,

- Marital status,
- Educational attainment, and
- Household size.

The questions raised in the assessment on the topic of international migration related characteristics are country of birth and country of citizenship. The census contains questions, which help to collect information on immigrants and return migrants such as "Have you ever lived outside the country?" and "when did you arrive in this country?" The *Census 2011* covers labour related characteristics of all current household members aged 15 years and over, such as employment status, industry/economic sector, and status in employment.

In the *Census 2011*, "*employment*" covers all persons who are 15 years of age or older and work at least one hour to earn remuneration, or are temporarily absent from work during the reference period. To classify industry, status in employment, and education, internationally adapted classifications are applied. For example:

- NACE, NAICS,
- Eurostat Regulation of classification for status in employment, and
- ISCED-1997.

Micro data is available for research and analysis outside the agency at less than 1000 EURO.

The *Labour Force Survey* commenced in 1983, and is held every three months by the Statistics Belgium. A completed sample size of the examination is 42,240 households with 83,686 individuals. It geographically measures the whole country and amasses information on the following three population groups aged 15 years and over:

- *Nationals (citizens) in the country,*
- *Nationals (citizens) employed in the country, and*
- *Foreign workers (non-citizens) living in the country*

The *Labour Force Survey* obtains detailed data on demographic characteristics of each person in a household, such as age, sex, marital status, educational attainment, and household size. Statistics on the international migration related characteristics presented through the source are country of birth and nationality. For the population groups assessed in the *Labour Force Survey*, the data on labour related characteristics is available, particularly for:

- Employment status,
- Occupation,
- Industry/economic sector,
- Status in employment,
- Wage or earnings rate per time period,
- Hours usually worked, and
- Whether person has had disability.

In the *Labour Force Survey*, "*international migrant workers*" covers naturalized persons (persons of Belgian nationality and born outside Belgium), EU nationals (whose country of nationality is an EU-27 country), and non-EU citizens. "*Employment*" is defined by the standard ILO definition.

To classify occupation, industry, status in employment, and education, internationally adapted classifications are applied. For example:

- ISCO-08 (where four digits are used to release the data),
- NACE, NAICS (where two digits are used to release the data),
- ICSE-1993, and
- ISCED-2011.

Micro data is available for research and analysis outside the agency at 500 euro.

The **Household Budget Survey** commenced in 1999, and is held every two years by the Statistics Belgium. A completed sample size of the examination is 43,486 households. It geographically measures parts of country covering three regions of Brussels-Capital, Flanders, and Wallonia and amasses information on the following three population groups of all ages:

- *Nationals (citizens) in the country,*
- *Nationals (citizens) employed in the country, and*
- *Foreign workers (non-citizens) living in the country.*

The **Household Budget Survey** obtains detailed data on demographic characteristics of each person in a household, such as age, sex, marital status, educational attainment, and household size. Statistics on the international migration related characteristics presented through the source are country of birth and country of citizenship. The **Household Budget Survey** also includes questions about remittances sent and remittances received by the household from someone living abroad. For the population groups assessed in the source, the data on labour related characteristics of all household members of all ages is available, particularly for:

- Employment status,
- Occupation,
- Industry/economic sector,
- Status in employment,
- Household income,
- Wage or earnings rate per time period,
- Hours usually worked, and
- Whether person has had disability.

The survey also includes questions on the following possible benefits received from the employer:

- Unemployment benefits;
- Health insurance or subsidized health care;
- Retirement pension;
- Paid vacation;
- Subsidized housing;
- Free or subsidized food; and
- Other benefits (incapacity for work or disability benefits; birth premium; family allowances; scholarships and travel; allowances from C.P.A.S.; other social allowances and allowances awarded by public services, part paid by unemployment)

In the **Household Budget Survey**, "**employment**" is defined by the definition of the ILO in the framework of the LFS (**Labour Force Survey**). To classify occupation, industry, and education, internationally adapted classifications are applied. For example:

- ISCO-88 (where two digits are used to release the data),
- NACE, NAICS (where two digits are used to release the data), and
- ISCED.

Micro data is available for research and analysis outside the agency at 500 euro for whatever file size.

The **Wage Structure Survey** is carried out on annual basis starting from 1999 by the Statistics Belgium with a completed sample size of about 10, 500 establishments. The survey covers all establishments with at least ten workers/employees in formal sectors and whole country. The **Wage Structure Survey** covers the following topics for the establishment:

- Industry/economic sector, and

- Number of employees.

The questions raised in the assessment on the topic of demographic and international migration related characteristics are:

- Age,
- Sex,
- Educational attainment,
- Country of birth, and
- Nationality.

The survey covers labour related characteristics, such as occupation, wage rate, and data of beginning to work for company.

"**Employment**" covers an individual who is bound to the company by a contract of employment. "**Wages**" refer to the gross salary for fully paid hours. To classify occupation, industry, and education, internationally adapted classifications are applied. For example:

- ISCO-08 (where three digits are used to release the data),
- NACE, NAICS (where two digits are used to release the data), and
- ISCED-2011.

Micro data is available for research and analysis outside the agency at 500 euro.

The **Data Warehouse of Labour Market and Social Protection** is a data from government/public employment services, which is carried out by the Crossroads Bank for Social Security (BCSS) and released at the request of the user, starting from 1998. The source appraises whole country and collects data on the following eight population groups of all ages.

- *Nationals (citizens) in the country,*
- *Nationals (citizens) employed in the country,*
- *Nationals (citizens) living abroad,*
- *Nationals (citizens) living and working abroad,*
- *Foreigners (non-citizens) living in the country,*
- *Foreign workers (non-citizens) living in the country,*
- *Asylum seekers, and*
- *Foreigners living abroad and working in the country.*

In the register, data can be found on demographic characteristics such as age, sex, marital status, and educational attainment. International migration related characteristics accessible through the source are:

- Country of birth,
- Year of arrival,
- Reason for coming to country,
- Nationality,
- Foreign workers in the country,
- Country of origin, and
- Country of previous residence.

For the population groups assessed in the **Data Warehouse of Labour Market and Social Protection**, the data on labour related characteristics is available, particularly for employment status, industry/economic sector, and status in employment.

In the *Data Warehouse of Labour Market and Social Protection*, "*international migrant workers*" are measured in various ways; persons who are born abroad, have a foreign nationality, a first foreign nationality, have parents with a (first) foreign nationality; persons are new to Belgium. People who live in Belgium and work abroad or who live abroad and work in Belgium are also determined. "*Nationals living abroad*" are only persons who have registered on the national register via a diplomatic post and / or who are still linked to Belgian social security are known. "*Employment*" covers persons who are declared to the Belgian Social Security as an employee.

To classify industry and education, internationally adapted classifications are applied. For example:

- NACE, NAICS (where three digits are used to release the data), and
- ISCED.
