Summary: Burkina Faso has reported 6 metadata sources, which collect information on international labour migration statistics. These are *General Population and Housing Census*, *National Survey on Employment and Informal Sector in Burkina Faso 2015*, *Living Conditions of Households Survey 2014*, *Continuous Multi-sectorial Survey 2014*, *Module Demography and Health of the Continuous Multi-sectorial Survey 2015*, and *The 6th Industrial and Commercial Census*, which are carried out by the National Institute of Statistics and Demographics.

Geographically all of the sources cover whole country, except to the *6th Industrial and Commercial Census*, which covers 22 localities of Burkina Faso. Statistics on the following four population groups are compiled in all the sources:

- *Nationals (citizens) in the country,*
- *Nationals (citizens) employed in the country,*
- *Foreigners (non-citizens) living in the country, and*
- *Foreign workers (non-citizens) living in the country.*

Periodicity of data collection varies depending on the type of sources. The *General Population and Housing Census* in Burkina Faso was last processed in 2006; the *National Survey on Employment and Informal Sector in Burkina Faso 2015* was first carried out in July 2015; the *Living Conditions of Households Survey 2014* was first carried out in 2009-2010 using the new methodology; the *Continuous Multi-sectorial Survey 2014* was first carried out 2014 using the new methodology; the *Module Demography and Health of the Continuous Multi-sectorial Survey 2015* was carried out in April 2015; and the *6th Industrial and Commercial Census* is held every five years starting from 2008.

Except the *General Population and Housing Census*, where the age coverage is five years and older, other sources cover population groups of all ages.

The five essential demographic characteristics covered by the census and household surveys are age, gender, marital status, educational attainment, and household size. International migration characteristics covered by most of the sources include country of birth and nationality. The *General Population and Housing Census* include information and characteristics of household members who left to live abroad in the past five years. Labour related characteristics covered by the *General Population and Housing Census*, the *National Survey on Employment and Informal Sector in Burkina Faso 2015*, the *Living Conditions of Households Survey 2014*, and the *Continuous Multi-sectorial Survey 2014* comprise of employment status, occupation, industry/economic sector, status in employment, and hours usually worked.

To classify occupation, industry, status in employment, and status in education all the sources apply the Classification of activities (and products) of Member States of Afristat (NAEMA). Micro-data only from *General Population and Housing Census* is available in free of charge.

Findings:

The latest *General Population and Housing Census* in Burkina Faso was carried out in 2006 by the National Institute of Statistics and Demographics covering the country's entire population. There are four population groups examined in the *General Population and Housing Census*:

- *Nationals (citizens) in the country,*
- *Nationals (citizens) employed in the country,*
- *Foreigners (non-citizens) living in the country, and*
- *Foreign workers (non-citizens) living in the country.*

The ***General Population and Housing Census*** obtains detailed data on demographic characteristics of these population groups. The questions raised in the assessment on the topic of international migration related characteristics, comprise of country of birth and country of citizenship. Statistics on household members that have left the country to live abroad in the last 5 years are collected and cover the following characteristics of these persons: name, month/year of departure, sex, and age at time of leaving household. In addition, the ***General Population and Housing Census*** covers labour related characteristics of all current household members aged five years and older such as:

- Employment status,
- Occupation,
- Industry/economic sector, and
- Status in employment.

To classify occupation, industry, and status in employment the Classification of activities of Member States of Afristat (NAEMA) is applied. The classification used to define the status in education is the Classification of activities and products of Member States of Afristat (NAPEMA).

The ***National Survey on Employment and Informal Sector in Burkina Faso 2015*** commenced in 2015, and was held first time in July 2015 by the National Institute of Statistics and Demographics. It geographically measures the whole country and amasses information on the following four population groups of all ages:

- *Nationals (citizens) in the country,*
- *Nationals (citizens) employed in the country,*
- *Foreigners (non-citizens) living in the country and,*
- *Foreign workers (non-citizens) living in the country.*

The ***National Survey on Employment and Informal Sector in Burkina Faso 2015*** retrieves the data on demographic characteristics, of each person in a household. The questions raised in the assessment on the topic of international migration related characteristics, comprise of country of birth and nationality.

The statistics are collected every five years, geographically covering 22 localities of the country. The survey appraises all enterprises of any size and covers the following topics for the establishment:

- Industry/economic sector, and
- Number of employees.

In the survey the data on demographic characteristics such as sex can be found. Question on nationality of persons is asked in the *6th Industrial and Commercial Census*.

To classify occupation, industry, status in employment, and status in education the Classification of activities of Member States of Afristat (NAEMA) is applied. Micro data files are not available for research and analysis outside the institute.
