Summary: The Democratic Republic of Congo has reported 6 metadata sources, which collect information on international labour migration statistics. There are three survey based sources such as *Scientific Census of Population* and *Employment Survey – Informal Sector – Consumption of Households*, which are carried out by the National Institute of Statistics, and the *Establishment of Financial Statements of Enterprises of the DR of Congo*, which is carried out by the Permanent Council of Accounting. There are two administrative records, such as *Issuance of Visas* held by the General Directorate of Migration and the *Register of National Identification* held by the General Secretariat of the Ministry of National Economy. Lastly there is an *estimation of international migrant workers*, which is carried out by the Ministry of Employment and Labour.

Geographically all of the sources cover whole country, however different population groups such as:

- Nationals (citizens) in the country (covered by the Scientific Census of Population, the Employment Survey Informal Sector Consumption of Households, the Register of National Identification, and the estimation of international migrant workers),
- Nationals (citizens) employed in the country (covered by the Scientific Census of Population, the Employment Survey – Informal Sector – Consumption of Households, and the estimation of international migrant workers),
- Foreigners (non-citizens) living in the country (covered by the Scientific Census of Population, the Employment Survey Informal Sector Consumption of Households, and the estimation of international migrant workers),
- Foreign workers (non-citizens) living in the country (covered by the Scientific Census of Population, the Employment Survey Informal Sector Consumption of Households, the Register of National Identification, and the estimation of international migrant workers),
- Refugees (covered by the Scientific Census of Population and the Issuance of Visas),
- Asylum seekers (covered by the Issuance of Visas),
- Child workers (non-citizens) in country (covered by the **Employment Survey Informal Sector –** Consumption of Households and the estimation of international migrant workers),
- Entry nationals (citizens) returning from residence abroad (covered by the Issuance of Visas),
- Exit nationals (citizens) going abroad to live (covered by the **Issuance of Visas**), Exit nationals (citizens) leaving for temporary purposes (covered by the **Issuance of Visas**),
- Foreigners (non-citizens) entering the country to live (covered by the **Issuance of Visas**),
- Foreigners (non-citizens) entering country for temporary purposes (covered by the **Issuance of Visas**), and
- Transit migrants (covered by the **Issuance of Visas**).

Periodicity of data collection varies depending on the type of source. The Scientific Census of Population in Congo, DR was last processed in 1984; the Employment Survey – Informal Sector – Consumption of Households was last carried out in 2012 starting from 2005; the Establishment of Financial Statements of Enterprises of the DR of Congo collects the data annually starting from 1975. The record of Issuance of Visas and the Register of National Identification are carried out continuously. The estimation of international migrant workers in the country is held every month.

Except to the *Scientific Census of Population*, where the age coverage of labour related characteristics is 6 years and older, other sources cover population groups of all ages.

The five essential demographic characteristics such as age, gender, marital status, educational attainment, and household size are covered by the *Scientific Census of Population*, the *Employment Survey – Informal Sector – Consumption of Households*, and the *estimation of international migrant workers*. In the *Issuance of Visas*

the data on the household composition can be found. International migration related characteristics vary depending on the source, question on country of birth is covered by all the sources. The *Scientific Census of Population* include information and characteristics of household members who left to live abroad for at least 6 months. Labour related characteristics are compiled in all the sources, the *Employment Survey – Informal Sector – Consumption of Households* contains the biggest variety of questions related to labour characteristics, such as employment status, occupation, industry/economic sector, status in employment, hours usually worked, individual earnings, household income, wage rates, and months worked in past year. Data from all the sources are not published or disseminated as there are some limitations exist, such as financial restrictions, security limitations, and insufficient data.

In the *estimation of international migrant workers* agency adapted definition of "*international migrant workers*" is used. To define "*nationals living abroad*" terms "*diaspora*" or "*congolais from abroad*" are applicable.

To classify occupation, industry, and status in employment internationally adapted classifications are used in the Scientific Census of Population, the estimation of international migrant workers, and the Establishment of Financial Statements of Enterprises of the DR of Congo. The Employment Survey – Informal Sector – Consumption of Households, the Issuance of Visas, and the Register of National Identification apply nationally adapted classifications.

Micro data files from the surveys, administrative records, and the estimation are unavailable for research and analysis outside the agencies.

Findings:

The latest *Scientific Census of Population* in the Democratic Republic of Congo was carried out in 1984 by the National Institute of Statistics covering the country's entire population. There are five population groups examined in the *Scientific Census of Population*:

- *Nationals (citizens) in the country,*
- Nationals (citizens) employed in the country,
- Foreigners (non-citizens) living in the country,
- Foreign workers (non-citizens) living in the country, and
- Refugees.

The *Scientific Census of Population* obtains detailed data on demographic characteristics of these population groups. The questions raised in the assessment on the topic of international migration related characteristics, comprise of country of birth, country of citizenship, second country of citizenship, country of previous residence for foreigners, and country of previous residence for citizens who lived abroad but returned. Statistics on household members that have left the country to live abroad for at least six months are collected. In addition to demographic characteristics, *Scientific Census of Population* covers labour related characteristics of all current household members aged 6 years and older such as:

- Employment status,
- Occupation,
- Industry/economic sector,
- Status in employment, and
- Disability.

To classify occupation, industry, status in employment, and education in the Democratic Republic of Congo the following classifications are applied. For example:

- ISCO 68;
- ISIC rev 3;
- ICSE 1958; and
- National adaptation of ISCED.

Micro-data files on population groups covered by the *Scientific Census of Population* are unavailable for research or analysis outside the agency.

The *Employment Survey – Informal Sector – Consumption of Households* in Congo, DR commenced in 2005, and the last time it was held in 2012 by the National Institute of Statistics. The completed sample size contains 22,276 households of 90,240 individuals. It geographically measures the whole country and amasses information on the following five population groups of all ages:

- *Nationals (citizens) in the country,*
- Nationals (citizens) employed in the country,
- Foreigners (non-citizens) living in the country,
- Foreign workers (non-citizens) living in the country, and

• Child workers (non-citizens) in the country.

The *Employment Survey – Informal Sector – Consumption of Households* retrieves the data on demographic characteristics, of each person in a household. Information about international migration characteristics includes country of birth, country of citizenship, nationality, foreign workers in the country, country of previous residence for foreigners, and country of origin. The data on labour related characteristics is available, particularly for:

- Employment status,
- Occupation,
- Industry/economic sector,
- Status in employment,
- Individual earnings per month,
- Household income,
- Wage or earnings rate per time period,
- · Hours usually worked, and
- Months worked in past year.

In addition to labour characteristics, the following information on benefits that he or she may receive from the employer is collected:

- Subsidized housing,
- Health insurance or subsidized health care,
- Paid vacation, and
- Scholarships, New Year bonus, profitability.

The household survey questionnaire includes questions on the remittances received from anyone abroad.

To classify occupation, industry, status in employment, and status in education nationally adapted classifications are applied such as:

- National adaptation of ISCO;
- National adaptation of ISIC;
- National adaptation of ICS; and
- National adaptation of ISCED.

Micro data is unavailable for research and analysis outside the National Bureau of Statistics.

Border/Admission Statistics are covered by the **Issuance of Visas** data obtained from the General Directorate of Migration. The data collection is continuously carried out by the agency. It processes the following eight population groups of all age groups:

- Entry nationals (citizens) returning from residence abroad,
- Exit nationals (citizens) going abroad to live,
- Exit nationals (citizens) leaving for temporary purposes,
- Foreigners (non-citizens) entering country to live,
- Foreigners (non-citizens) entering country for temporary purposes,
- Refugees,
- Asylum seekers, and
- Transit migrants.

The statistics cover demographic characteristics such as: age, marital status, sex, and household composition on those entering/leaving. The following migration related topics are covered:

- Country of birth,
- Country of citizenship,
- Country of residence,

- Reason for coming to country,
- Intended duration of stay,
- Country of destination,
- Country of origin,
- Year of arrival, and
- Time period allowed to stay.

To collect evidence on labour related characteristics the question on employment status, occupation, and industry/economic sector are raised at the source.

Micro data files are available on request from the government service at various costs as it is difficult to estimate it.

The *Establishment of Financial Statements of Enterprises of the DR of Congo* was last carried out in 2014 by the Permanent Council of Accounting. The statistics are collected every year starting from 1975, geographically covering the whole country. The survey appraises all economic establishments of any size in formal sector only and covers the following topics for the establishment:

- Industry/economic sector,
- Number of employees, and
- Profit/loss in most recent year available.

In the survey the data on demographic characteristics, such as sex and age can be found. Questions related to migration characteristics are asked on the nationality and country of birth of employees of the establishments. Information on occupation of persons is collected in the *Establishment of Financial Statements of Enterprises of the DR of Congo*.

To classify occupation and industry, internationally adapted classifications are applied in the source, such as ISCO-68 and ISIC rev 2. Micro data files are unavailable for research and analysis outside the agency.

The *Register of National Identification* in Congo, DR is carried out on continuously basis by the Directorate of Education and Planning/General Secretariat of the Ministry of National Economy. The source geographically appraises the whole country and collects data on the following two population groups of all ages:

- Nationals (citizens) in the country, and
- Foreigners (non-citizens) living and working in the country.

In the register, sex is collected for data on demographic characteristics. Migration related characteristics accessible through the source are:

- Country of birth,
- Country of citizenship,
- · Nationality, and
- Country of origin.

The register additionally provides labour related information, specifying industry/economic sector, for which the national adaptation of ISIC is used.

The *estimation of international migrant workers in the country* is held every month by the Directorate of Education and Planning/Ministry of Employment and Labour. This covers the whole country and the following five population groups of all ages:

- *Nationals (citizens) in the country,*
- Nationals (citizens) employed in the country,
- Foreigners (non-citizens) living in the country,
- Foreigners (non-citizens) living and working in the country, and
- Child workers (non-citizens) in the country.

It accumulates data on demographic characteristics of people such as age, sex, educational attainment, marital status, and household size. Statistics on migration related characteristics are also obtained, precisely on:

- Country of birth,
- Country of citizenship,
- Country of previous residence,
- Duration of stay in country to date,
- Nationality,
- Foreign workers in the country, and
- Country of previous residence of foreign workers in the country.

Labour related characteristics collected in the estimation are: employment status, occupation, industry/economic sector, status in employment, individual earnings, and wage rates.

"International migrant workers" in the estimation are defined as persons who left their countries to work in another country and have working permits. The terms commonly used to define "national living abroad" are "diaspora" or "Congolais from abroad".
