EGYPT

Region: Africa

Income group: Lower-middle income

Summary: Egypt has reported 5 metadata sources, which collect information on international labour migration statistics. There are two survey based sources such as *Population, Housing and Establishment Census and Household International Migration Survey*, which are carried out by the Central Agency for Public Mobilization and Statistics (CAMPAS). There the following three administrative records:

- Border/Admission Statistics held by the Ministry of Interior;
- The register of Work Permits for Nationals to Work Abroad held by the Ministry of Interior; and
- The register of *Work Permits Issued to Foreign Workers* held by the Ministry of Manpower and Migration.

Geographically all of the sources cover whole country, however different population groups. The statistics on the following population groups are available:

- Nationals (citizens) in the country (covered by the Population, Housing and Establishment Census, Household International Migration Survey, and the register of Work Permits for Nationals to Work Abroad),
- Nationals (citizens) employed in the country (covered by the **Population, Housing and Establishment** Census, the **Household International Migration Survey**, and the register of **Work Permits for Nationals** to **Work Abroad**),
- Nationals (citizens) living abroad (covered by the Household International Migration Survey),
- Nationals (citizens) living and working abroad (covered by the Household International Migration Survey and the register of Work Permits for Nationals to Work Abroad),
- Foreigners (non-citizens) living in the country (covered by the Population, the Housing and Establishment Census, Household International Migration Survey, and the Work Permits Issued to Foreign Workers),
- Foreign workers (non-citizens) living in the country (covered by the Population, the Housing and Establishment Census, Household International Migration Survey, and the Work Permits Issued to Foreign Workers),
- Refugees (covered by the Household International Migration Survey and the Border/Admission Statistics).
- Entry nationals (citizens) returning from residence abroad (covered by the **Border/Admission Statistics**),
- Exit nationals (citizens) going abroad to live (covered by the **Border/Admission Statistics**),
- Exit nationals (citizens) leaving for temporary purposes (covered by the **Border/Admission Statistics**), and
- Foreigners (non-citizens) entering country for temporary purposes (covered by the **Border/Admission** Statistics).

Periodicity of data collection varies depending on the type of source. All the three administrative records are carried out on continuously basis; the *Household International Migration Survey* was held for the first time in January 2013.

The sources cover different age groups of persons examined. For instance, the *Household International Migration Survey* and the register of *Work Permits for Nationals to Work Abroad* generate statistics on persons aged 15 years and over. The register of *Work Permits Issued to Foreign Workers* collects the data on persons starting from 18 years old, and the *Border/Admission Statistics* record persons of all ages.

Both surveys and administrative records collect the data on the following topics, such as demographic characteristics, migration related characteristics, and labour related characteristics. The four essential

demographic characteristics covered by the surveys and the register of *Work Permits Issued to Foreign Workers* are age, gender, marital status, and educational attainment. In addition to these, in the surveys the data on household size can be found. The *Border/Admission Statistics* and the register of *Work Permits for Nationals to Work Abroad* also obtain demographic characteristics, but not for all the variables. International migration related characteristics vary depending on the source. All the sources accumulate statistics on the country of birth and country of citizenship. The *Household International Migration Survey* and the register of *Work Permits Issued to Foreign Workers* also compile data on foreign workers in the country. The surveys collect information on household members who left to live abroad, especially in the *Household International Migration Survey* the detailed characteristics of these persons are obtained. Labour related characteristics such as employment status, occupation, industry/economic sector, and status in employment are accessible through all five sources.

Information on immigrants and return migrants is generated in the *Household International Migration Survey*, specifically the data is available on the on employment status, status in employment, reason for choosing to migrate to this country, and reason for leaving previous country of residence.

The data from the administrative records is sent to the Central Agency for Public Mobilization and Statistics. Both statistics, from surveys and administrative sources, are disseminated and published by this agency.

The surveys apply nationally adapted definitions of "employment" and "national living abroad". "International migrant workers" in the Household International Migration Survey are non-citizens who identified as potential forced migrants and who are currently 15 years and over. "Overseas visitors" definition is applied in the record of Border/Admission Statistics and includes all passengers who arrive to the country.

The classifications used for occupation and industry in the surveys are national adaptation. For the status in employment and education the internationally adapted classifications are applied.

Micro data files are unavailable for research and analysis outside the agencies.

Findings:

Population, Housing and Establishment Census in the Egypt was carried out in 2006 by the Central Agency for Public Mobilization and Statistics covering the country's entire population. There are four population groups examined in the **Population, Housing and Establishment Census**:

- Nationals (citizens) in the country,
- Nationals (citizens) employed in the country,
- Foreigners (non-citizens) living in the country, and
- Foreign workers (non-citizens) living in the country.

The *Population, Housing and Establishment Census* obtain detailed data on demographic characteristics of these population groups. The questions raised in the assessment on the topic of international migration related characteristics, comprise of country of birth, country of citizenship and country of previous residence for citizens who lived abroad but returned. Statistics on household members that have left the country to live abroad are collected and refer to the last time the person left without any age or other limitations. In addition to demographic characteristics, *Population, Housing and Establishment Census* covers labour related characteristics of household members that have left to live abroad such as:

- Employment status,
- Occupation,
- Industry/economic sector,
- Status in employment, and
- Disability.

In order to measure "employment", nationally adapted definition is used, which specifies the age of economically active population (15+), reference period (one week), and individuals assigned to a job but couldn't practice it due to various reasons. "National living abroad" are defined as the household members who live abroad 6 months or more. To classify occupation and industry nationally adapted classifications are applied. For example:

- National Adaptation of ISCO-88, (where six digits are used to release the data);
- National Adaptation of ISIC rev 4 (where six digits are used to release the data);

To classify status in employment and status in education internationally adapted classifications are used, such as ICSE-1993 and ISCED-1997.

Micro-data files on population groups covered by the *Population, Housing and Establishment Census* are unavailable for research and analysis outside NSO.

The *Household International Migration Survey* in Egypt commenced in January 2013, and is held every by the Central Agency for Public Mobilization and Statistics. A completed sample size of the examination is 80,000 households, and 3,000 emigrants. It geographically measures the whole country and amasses information on the following seven population groups aged 15 years and over:

- *Nationals (citizens) in the country,*
- Nationals (citizens) employed in the country,
- Nationals (citizens) living abroad
- Nationals (citizens) living and working abroad,
- Foreigners (non-citizens) living in the country, even if arrived recently,
- Foreign workers (non-citizens) living in the country, and
- Refugees.

The *Household International Migration Survey* retrieves the data on demographic characteristics, of each person in a household. The statistics cover migration related characteristics such as:

• Country of birth,

- Country of previous residence for foreigners,
- Country of previous residence for citizens who lived abroad but returned,
- Nationality,
- Foreign workers in the country,
- Household members living abroad,
- Country of origin, and
- Remittances received from anyone abroad or sent to any absent household member living abroad.

Information and characteristics of household members for the period of 13 years, aged 15 and over that have left the country to live abroad for at least six months are presented in the survey. Questions on recruitment abroad and need for assistance are also included. For the population groups assessed in the survey, the data on labour related characteristics is available, particularly for:

- Employment status,
- Occupation,
- Industry/economic sector, and
- Status in employment.

The *Household International Migration Survey* includes questions on the following possible benefits that persons receive from employer:

- Retirement pension,
- Subsidized housing,
- Health insurance or subsidized health care,
- Paid vacation.
- Free or subsidized food, and
- Pay for overtime work, maternity leave or vacation parental care, compensation for work injuries, and paid sick leave.

Information on immigrants and return migrants is generated through questions such as 'Have you ever lived outside this country?' and 'When did you arrive in this country?' Moreover, the following data is obtained on the situation at the time prior to leaving the previous country of residence before coming to this country: employment status, status in employment, reason for choosing to migrate to this country, and reason for leaving previous country of residence.

"International migrant workers" in the survey are defined as "forced migrants" who are non-citizen aged 15 years and more. "National living abroad" is described as a person who used to live in the sample household and who is currently abroad and aged 15 years and more. Definition of "employment" is the same as in the Population, Housing and Establishment Census.

To classify occupation and industry nationally adapted classifications are applied. For example:

- National Adaptation of ISCO-88, (where 6 digits are used to release the data);
- National Adaptation of ISIC rev 4 (where 6 digits are used to release the data);

To classify status in employment and status in education internationally adapted classifications are used, such as ICSE-1993 and ISCED-1997.

Micro-data files are unavailable for research and analysis outside NSO.

Border/Admission Statistics data is obtained from the Ministry of Interior. This category of source originated in Egypt where the data collection is continuously carried out by the agency. It processes the following five population groups of all age groups:

- Entry nationals returning from residence abroad,
- Exit nationals going abroad to live,
- Exit nationals leaving for temporary purposes,

- Foreigners (non-citizens) entering country for temporary purposes, and
- Refugees.

The source obtains demographic characteristics of these persons, such as age and educational attainment. The statistics cover migration related characteristics such as:

- Country of birth,
- Country of citizenship,
- Country of residence,
- Country entering from,
- Reason for departure,
- Reason for coming to country,
- Country of destination,
- Country of origin,
- Year of arrival, and
- Time period allowed to stay.

To collect evidence on labour related characteristics the question on employment status and occupation is raised at the source. All the data collected through the record is sent to CAMPAS, where it is disseminated.

All the passengers arriving to the country regardless of the purpose of the visit are described as "overseas visitors". Micro-data files are unavailable outside the agency.

The Register of Work Permits for Nationals to Work Abroad is carried out by Ministry of Interior on continuously basis, starting from 1984. The source geographically appraises the whole country and collects data on the nationals (citizens) in the country, nationals (citizens) employed in the country, and nationals (citizens) living and working abroad of 15 years old and over. In the register, data can be found on demographic characteristics such as sex and educational attainment. Migration related characteristics accessible through the source are:

- Country of birth,
- Country of citizenship,
- Nationality,
- · Country of origin, and
- Destination country.

Moreover, it specifies employment status, occupation, industry/economic sector, status in employment and individual earnings of population groups covered in the administrative record. All the data collected through the record is sent to CAMPAS, where it is disseminated.

Micro-data files are unavailable outside the agency.

The *Register of Work Permits Issued to Foreign Workers* is held continuously by the Ministry of Manpower and Migration. It covers the whole country and amasses information on the following population groups of 18 years and older:

- Foreigners (non-citizens) living in the country,
- Foreigners (non-citizens) living and working in the country,
- Refugees, and
- Asylum seekers.

Demographic characteristics such as age, marital status, sex, and educational attainment are accessible though the register. Question on international migration characteristics are asked including country of birth, country of citizenship, year of arrival, time period allowed to stay, reason for coming to country, nationality, and foreign workers in the country. Labour related characteristics of persons examined such as employment status, occupation, industry/economic sector, and status in employment are covered in the source.
