Summary: Zambia has reported 3 metadata sources, which collect information on international labour migration statistics such as the *Census of Population and Housing*, the *Economic Census*, and the *Employment and Earnings Inquiry Survey*, which are carried out by the Central Statistical Office.

Geographically all of the surveys cover whole country, the *Census of Population and Housing* obtains statistics on the following six population groups:

- Nationals (citizens) in the country,
- Nationals (citizens) employed in the country,
- Foreigners (non-citizens) living in the country,
- Foreign workers (non-citizens) living in the country,
- Refugees, and
- Asylum seekers.

The *Economic Census* and *Employment and Earnings Inquiry Survey* cover all economic establishments of all sizes and from all industries.

Periodicity of data collection varies depending on the type of sources. The *Census of Population and Housing* in Zambia was last processed in 2010; the *Economic Census* is carried out irregularly, the last one was in August 2011 starting from 2004; the *Employment and Earnings Inquiry Survey* collects the data every 3 months.

The *Census of Population and Housing* covers all essential demographic characteristics, whereas the *Economic Census* collects the data on sex and educational attainment. International migration related characteristics obtained in the sources are country of birth, nationality, and country of citizenship. Labour related characteristics, such as employment status, occupation, industry/economic sector, status in employment, and disability are available in the *Census of Population and Housing*. The *Economic Census* covers includes questions related to industry/economic sector, occupation, and status in employment of employees of the establishments. The *Employment and Earnings Inquiry Survey* obtains data on industry/economic sector and wage rates.

"Employment" is measured as an agreement between an employee and an employer with both in the Economic Census and the Employment and Earnings Inquiry Survey. "Wage" is defined as a monetary compensation or enumeration in the Economic Census and the Employment and Earnings Inquiry Survey.

To classify occupation, industry, status in employment, and education, internationally adapted classifications are applied in the sources.

Micro data files are available for research and analysis outside of the Central Statistical Office with different limitations depending on the source and free of charge.

Findings:

The latest *Census of Population and Housing* in the Zambia was carried out in 2010 by the Central Statistical Office covering the country's entire population. There are six population groups examined in the *Census of Population and Housing*:

- Nationals (citizens) in the country,
- Nationals (citizens) employed in the country,
- Foreigners (non-citizens) living in the country, even if arrived recently,
- Foreign workers (non-citizens) living in the country,
- Refugees, and
- Asylum seekers.

The *Census of Population and Housing* obtains detailed data on demographic characteristics of these population groups such as age, marital status, household size, sex, and educational attainment. The questions raised in the assessment on the topic of international migration related characteristics, comprise country of birth and country of citizenship. The *Population Census* covers labour related characteristics of all current household members such as:

- Employment status,
- Occupation,
- Industry/economic sector,
- Status in employment, and
- Disability.

To classify occupation, industry, status in employment, and education in Zambia, internationally adapted classifications are applied. For example:

- ISCO 08 (where four digits are used to release the data);
- ISIC rev 4 (where three digits are used to release the data);
- ICSE 1993; and
- ISCED 1997.

10% of micro-data set files on population groups covered by the *Census of Population and Housing* are available outside the agency for free. A written request to the Director of Census and Statistics is needed.

The *Economic Census* initially commenced in 2004. This last one was processed in August, 2011 geographically covering the whole country. It accumulates information on all establishments of any size, even with zero employees covering all industries/economic sectors, number of employees, labour turnover, and profit/loss in most recent year available.

The census obtains demographic and migration related characteristics for employees of the establishments such as sex, educational attainment, country of citizenship, and nationality. Labour related characteristics generated in the *Economic Census* include occupation and status in employment.

"Employment" refers to employment agreement between an employer and an employee that the employee will provide certain services on the job, and the employer's designated workplace, to facilitate the accomplishment of the employer organisation's goals and mission, in return for compensation. "Wage" is a monetary compensation or enumeration. The following classifications are used for occupation, industry, status in employment, and status in education:

- ISCO − 08;
- ISIC rev 4;
- ICSE 1993; and
- ISCED 2011.

Micro-data files are available for research and analysis outside the Central Statistical Office, the confidentiality has to be maintained.

The *Employment and Earning Inquiry Survey* is carried out every 3 months covering the entire country's population. The sample frame used in the survey is the *Economic Census* with a completed size of 2,000 establishments. This stipulates data on all economic establishments of any size covering all industries/economic sectors, number of employees, and total sales revenue or gross receipts. The survey assembles statistics on migration related characteristics such as country of citizenship and nationality of the employees of the establishments. It ask questions on wage rates.

"Employment" refers to employment agreement between an employer and an employee that the employee will provide certain services on the job, and the employer's designated workplace, to facilitate the accomplishment of the employer organisation's goals and mission, in return for compensation. "Wage" is a monetary compensation or enumeration. To classify occupation, industry, status in employment, and status in education the following classifications are applied:

- ISCO 08 (where four digits are used to release the data);
- ISIC rev 4 (where four digits are used to release the data);
- ICSE 1993; and
- ISCED 2011.

Micro data files are available for research and analysis outside the agency.
