## Effect to be given to the recommendations of sectoral meetings

Tripartite Meeting on Employment, Social Dialogue, Rights at Work and Industrial **Relations in Transport Equipment Manufacture** (Geneva, 10-12 January 2005)

- 1. The Tripartite Meeting on Employment, Social Dialogue, Rights at Work and Industrial Relations in Transport Equipment Manufacture was held in Geneva from 10-12 January 2005, and was chaired by Mr. Jan Sithole (Worker member of the Governing Body).
- 2. The Meeting was attended by Government representatives from: Algeria, Argentina, Brazil, Canada, Czech Republic, Indonesia, Islamic Republic of Iran, Republic of Korea, Malaysia, Morocco, Paraguay, Philippines, Portugal, Romania, Russian Federation, South Africa, Sudan, Syrian Arab Republic, Thailand, Ukraine and Venezuela, as well as ten Employer and ten Worker representatives. Representatives from the following international non-governmental organizations also attended as observers: the International Confederation of Free Trade Unions, the International Organisation of Employers and the International Metalworkers' Federation.
- 3. The Meeting considered a report prepared by the International Labour Office. <sup>1</sup>
- **4.** It unanimously adopted a set of conclusions on employment development, social dialogue and decent work in transport equipment manufacturing. These conclusions, together with a summary of the proceedings of the Meeting, appear in the Note on the proceedings, which is distributed with the present paper. <sup>2</sup> Paragraph 7 of the conclusions calls on the ILO to continue and update its work on a database for the metal trades industries.
- 5. The Committee on Sectoral and Technical Meetings and Related Issues may wish to recommend that the Governing Body authorize the Director-General to

communicate the Note on the proceedings containing the texts mentioned in paragraph 4 above:

- (a) to governments, requesting them to communicate these texts to the employers' and workers' organizations concerned;
- (b) to the international employers' and workers' organizations concerned; and
- (c) to the international organizations concerned.
- 6. The Committee on Sectoral and Technical Meetings and Related Issues may also wish to recommend that the Governing Body requests the Director-General to bear in mind, when drawing up proposals for the future work of the Office, the wishes expressed by the Meeting in paragraph 7 of the conclusions.
