SEVENTH ITEM ON THE AGENDA

Choice of Conventions and Recommendations on which reports should be requested in 2008 and 2009 under article 19 of the Constitution

- 1. The Committee is called upon to make proposals to the Governing Body regarding the choice of Conventions and Recommendations on which governments might be requested to submit reports in 2008 and 2009 under article 19, paragraphs 5(e), 6(d) and 7(b), of the Constitution. These provisions require member States to report "at appropriate intervals, as requested by the Governing Body" on non-ratified Conventions and Recommendations; the reports cover in particular the status of legislation and practice concerning the matters dealt with in these instruments, and should indicate the extent to which effect has been given or is proposed to be given to those instruments.
- **2.** Certain criteria were established in 1951 as to the demand for these reports. ¹ The Governing Body decided that they should be grouped by subject matter as far as possible and should be of current interest. It was also thought that not too many should be requested so as not to create excessive work for national administrations and the Committee of Experts. ²
- **3.** These reports, as well as those submitted under articles 22 and 35 of the Constitution by the States parties to the Conventions concerned, have, since 1955, ³ enabled the Committee of Experts on the Application of Conventions and Recommendations to carry out General Surveys on the effect given to the instruments considered. The General Surveys (Report III (Part 1B)) are examined by the Committee on the Application of Standards of the International Labour Conference in the framework of its general discussion.

- **4.** General Surveys are recognized as useful reference instruments to assess the status of national legislation and practice in any given area and, in particular, the extent to which effect has been given to the Conventions concerned in fact in the absence of ratification, as well as to the Recommendations. This information makes it possible to analyse the nature of the obstacles to the ratification or the application of the instruments and the type of action required to remove such obstacles. Broadly speaking, the General Surveys have an important role, not only in assessing the relevance of standards (by contributing to the identification of up to date standards calling for promotions or of standards ripe for revision), but also in the evaluation of their impact and in their promotion. They can also help achieve a better understanding of the obligations contained in the Conventions, including the flexibility provided for with regard to their application.
- **5.** Within the framework of its examination of the Conventions and Recommendations within its mandate, the Working Party on Policy regarding the Revision of Standards (hereafter, the "Cartier" group) has frequently based its analysis on such surveys. It also specifically recommended that General Surveys be established on instruments for which additional information was required. These General Surveys have all been carried out and the Working Party concluded its work in March 2002.
- **6.** One of the main outcomes of the work of the "Cartier" group was the identification of Conventions and Recommendations which are up to date and which thus merit extra effort regarding their promotion. ⁴ While not discarding the possibility of extending the choice to all of the standards in force, the proposal is to use this list, as was the case in 2004, to select the subjects that would be of most interest. Apart from the importance and relevance of the subject, it is suggested that certain additional (non-cumulative) criteria be applied, such as the complete absence of a General Survey on the subject, or a gap of at least ten years since the last one, requests for information on obstacles to ratification or application made by the Governing Body on the basis of the conclusions of the Working Party and which are still pending, ⁵ the low number of ratifications or even the existence of significant developments regarding national legislation. A total of 13 proposals have been put forward on the basis of these criteria.
- **7.** The standards proposed below have, for the most part, never been the subject of a General Survey and have elicited requests for information on the obstacles to ratification made by the Governing Body. In one case, the most recent survey was carried out over ten years ago.

■ *Labour relations:*

- (i) the Workers' Representatives Convention, 1971 (No. 135), and the Workers' Representatives Recommendation, 1971 (No. 143). An analysis of Convention No. 135 would provide useful information on the different systems for workers' representation around the world, the adequacy of protection and facilities for workers' representatives, and any observable impact that elected representatives may have on the existence of trade unions; or
- (ii) the Labour Relations (Public Service) Convention, 1978 (No. 151), the Labour Relations (Public Service) Recommendation, 1978 (No. 159), the Collective

Bargaining Convention, 1981 (No. 154), and the Collective Bargaining Recommendation, 1981 (No. 163). Conventions Nos. 151 and 154, which are key Conventions in the area of labour relations and protection of the right to organize in the public service, as well as the overall extension of collective bargaining to all workers, are particularly important for the development and extension of these rights to all categories of workers. The information collected could contribute to the implementation and promotion of these instruments.

- Occupational safety and health (general provisions): The Occupational Safety and Health Convention, 1981 (No. 155), the Occupational Safety and Health Recommendation, 1981 (No. 164), and the Protocol of 2002 to the Occupational Safety and Health Convention, 1981. Convention No. 155 is a key Convention in this field, but its rate of ratification does not reflect its importance. It is closely linked to the Promotional Framework for Occupational Safety and Health Convention, 2006 (No. 187). There is room for clarification regarding their complimentarity. The information gathered could help in both the application and promotion of the two instruments.
- Social security: The Social Security (Minimum Standards) Convention, 1952 (No. 102). The last complete General Survey dates back to 1961. The survey carried out in 1989 only covers Part V (old-age benefit). The Governing Body decision to invite member States to ratify this Convention also invites the Office to provide technical assistance where appropriate. A General Survey would make it possible to better focus this technical assistance.
- Specific categories of workers (nursing personnel): The Nursing Personnel Convention, 1977 (No. 149), and Nursing Personnel Recommendation, 1977 (No. 157). Members of this profession are particularly exposed to certain risks and may experience difficult working conditions. The Office has undertaken numerous studies in this regard, which it would be useful to develop further.
- **8.** The fundamental Conventions on which the last survey dates back to more than ten years ago include the following:
 - Equal remuneration: The Equal Remuneration Convention, 1951 (No. 100), and the Equal Remuneration Recommendation, 1951 (No. 90). The last General Survey dates back to 1986. A more up to date survey would be useful, given the numerous developments that have occurred in national legislation and national promotion policy.
 - Recommendation, 1973 (No. 146), the Worst Forms of Child Labour Convention, 1999 (No. 182), and the Worst Forms of Child Labour Recommendation, 1999 (No. 190). The last General Survey on Convention No. 138 dates back to 1981. In 2009, Convention No. 182 will be ten years old. The application of these Conventions could be improved by certain clarifications that could be made in a General Survey, for example regarding the determination of hazardous types of work. Should the Governing Body choose this subject, it would be preferable if it were selected for 2008 (and thus discussed at the 2009 session of the Conference), given that the next Global Report on this subject under the follow-up to the ILO Declaration on Fundamental Principles and Rights at Work is scheduled for 2010.
- **9.** Certain Conventions that date back 10 to 20 years are being ratified at a relatively slow rate. An analysis of these instruments and, in particular, of the obstacles to their ratification, could be especially useful in identifying problems and exploring possible solutions. Possible subjects include:

- Occupational health and safety (asbestos): The Asbestos Convention, 1986 (No. 162) (28 ratifications), and the Asbestos Recommendation, 1986 (No. 172). Asbestos is a particularly serious concern and highly relevant today. During its 95th Session (2006), the International Labour Conference adopted a resolution which invited the Office to continue to encourage member States to ratify this Convention and to give effect to its provisions.
- Working time: The Part-Time Work Convention, 1994 (No. 175) (11 ratifications), and the Part-Time Work Recommendation, 1994 (No. 182). Certain aspects of working time were addressed in the 2005 General Survey on the Hours of Work (Industry) Convention, 1919 (No. 1), and the Hours of Work (Commerce and Offices) Convention, 1930 (No. 30). The survey highlighted the tendency towards greater diversity of working time arrangements and flexibility. A survey on these instruments would provide a useful supplement to the information already available.
- *Wages:* the Protection of Workers' Claims (Employer's Insolvency) Convention, 1992 (No. 173), and the Protection of Workers' Claims (Employer's Insolvency) Recommendation, 1992 (No. 180). A General Survey could usefully supplement the 2003 survey on the Protection of Wages Convention, 1949 (No. 95), and the Protection of Wages Recommendation, 1949 (No. 85).
- Specific categories of workers:
 - (i) *Home work:* The Home Work Convention, 1996 (No. 177) (five ratifications), and the Home Work Recommendation, 1996 (No. 184). Despite the importance of the issue, this Convention has a particularly low ratification rate.
 - (ii) *Hotels and restaurants:* The Working Conditions (Hotels and Restaurants) Convention, 1991 (No. 172) (13 ratifications), and the Working Conditions (Hotels and Restaurants) Recommendation, 1991 (No. 179).
- **10.** Finally, it should be borne in mind that the General Survey discussed by the Conference in June 2006 covered labour inspection ⁸ and two priority Conventions in particular. The proposal to promote these instruments received wide support from the Conference. Labour administration is a subject that is closely linked to inspection and is also extremely important. A General Survey on the Labour Administration Convention, 1978 (No. 150), and the Labour Administration Recommendation, 1978 (No. 158), could also contribute to the improved promotion of these instruments.
