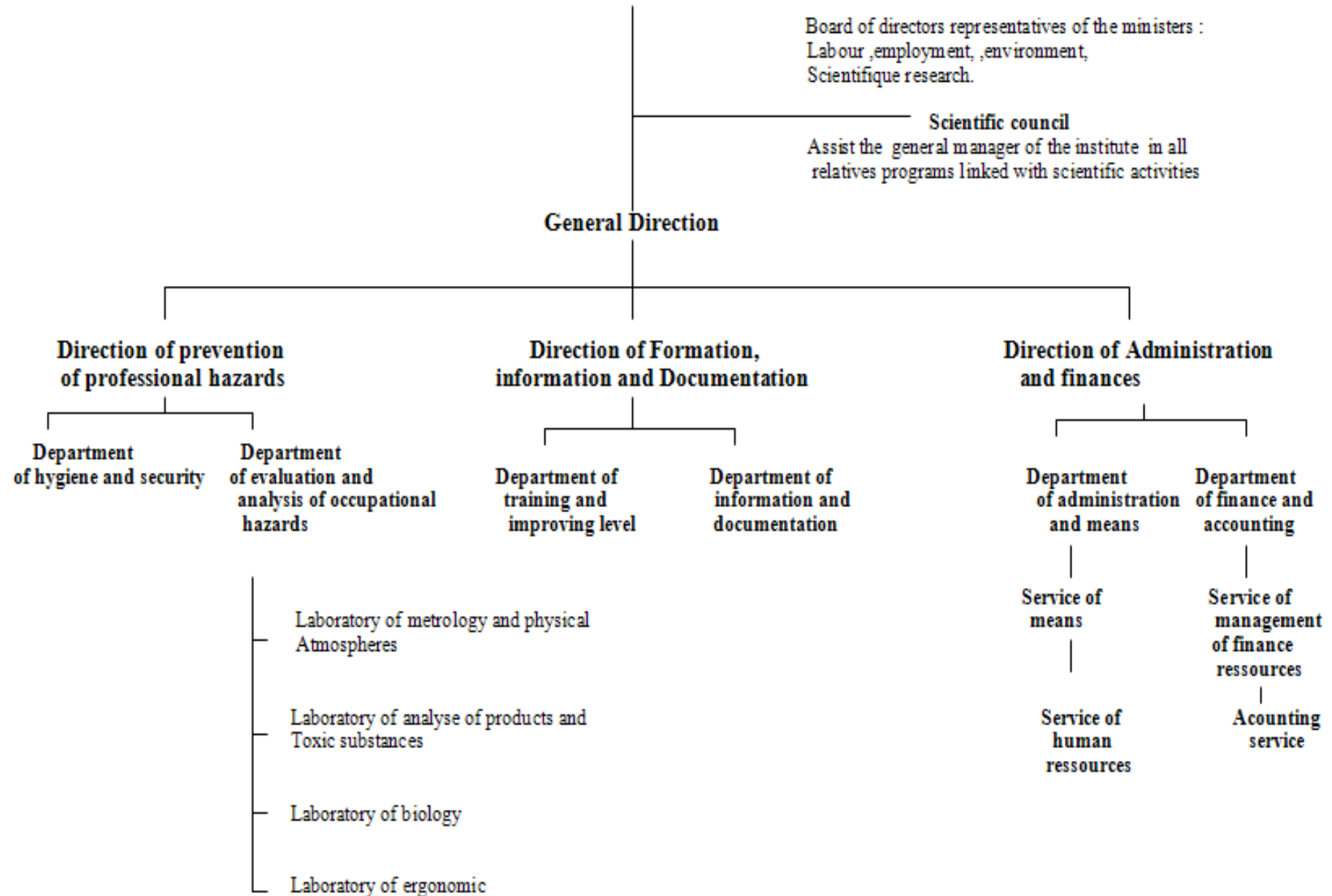

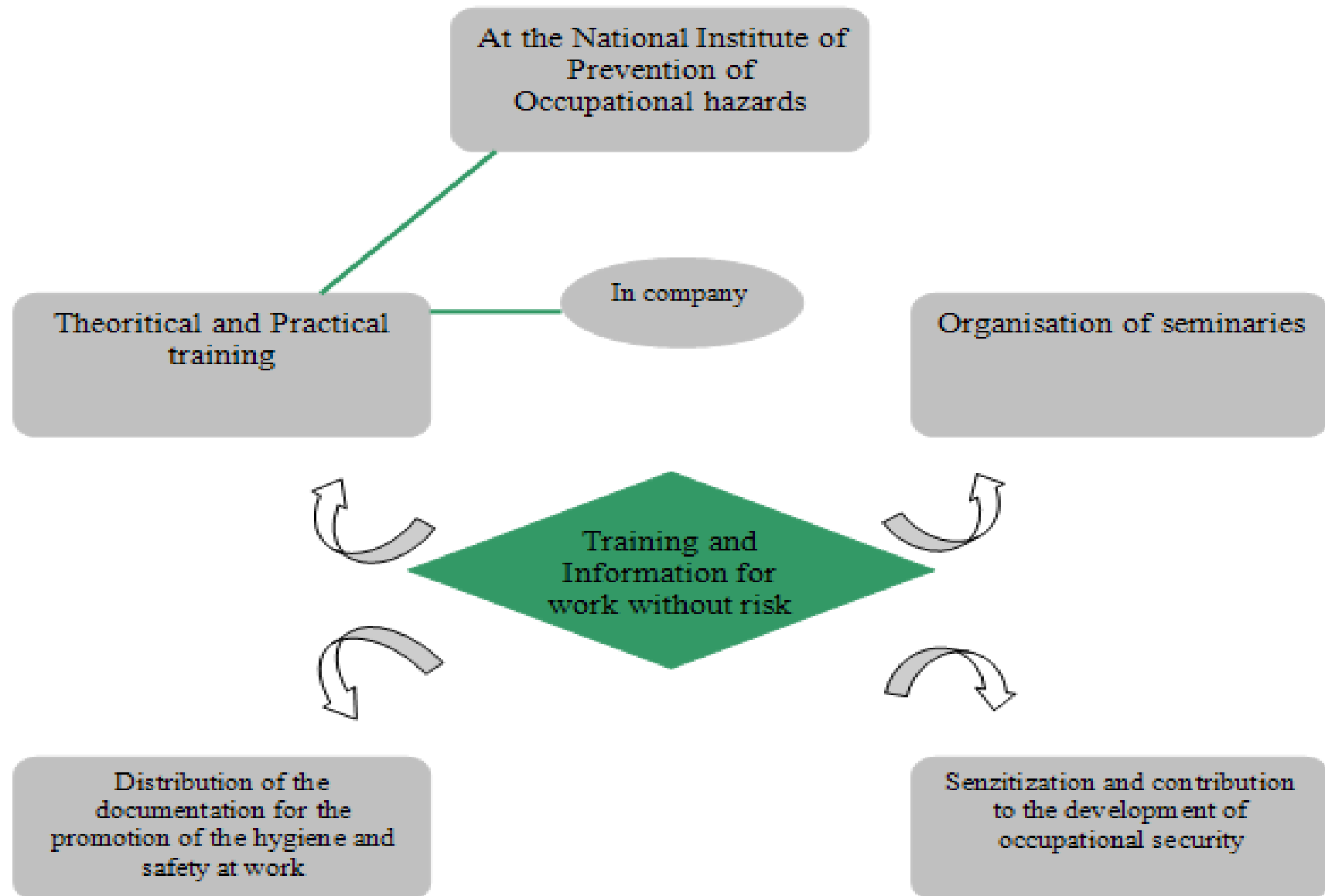

# TRAINING, INFORMATION AND DOCUMENTATION



***Among the legislative and statutory texts governing the prevention of occupational hazards, we shall quote particularly:***

- The law n°83-13 relative to the hygiene, the safety and the occupational medicine.
- - The law 90 - 17 relative to the protection and to the promotion of health which modifies and completes the law n°85-05.
- - The executive decree n°91-05 concerning the general prescriptions of applicable protection in mater of hygiene and safety at work.
- The executive decree n°97-427 concerning the occupational accidents and diseases
- The executive decree n°02-427 concerning the organization of the instruction, the information and the training of workers in the field of the prevention of the occupational hazards.
- - Executive decree n°05-09 concerning joint commissions and concerning employees of hygiene and security.

## Correspondence between the agreements of the ILO and the Algerian legislation:

- ALGERIA ratified 58 agreements since 1962 among which 29 deals with improving working conditions.

# ***Specific aspects in the information:***

- The National Institute of Prevention of Occupational Hazards is in charge of collecting and diffusing, by all the appropriate means, any information and documentation to promote the hygiene and the safety(conf. article 4 of the decree 2000-253 of August 23rd, 2000) by:
  - - The organization of seminars, open days, and study days.
- The participation in the events organized by the speakers concerned in the field of the prevention of the occupational hazards (economic expositions and fairs)
- To implement support of information developed by the institute(liflets,posters.....)
- The sensitization and the contribution in developing the security spirit and feeling.



- The strong interaction between aspects of information and training are present within the framework of the shaping of the modules of training, which have to take into account the sensitization and the information aspects in the prevention of occupational hazards.
- The training courses are joined to a concern aiming to inculcate the culture of the prevention of the occupational hazards in the various professional categories in training cycles.

# ***Information and instruction of the workers***

- The action of information and instruction are made on the scene of work:
- By the distribution of leaflets
- By the display of the posters of safety
- By the organization of conferences and information campaigns intended to workers.

# ***Collaboration of geneva CIS***

- Organization of the seminary of April 28th, 2007 carrying on the subject of the healthy and safe working places - to make some decent work a reality.

## ***Organization by the INPRP of the remembrance of the world day of the safety and the health in the work***

- April 28th, 2007, and following the example of the other member countries, Algeria through the The National Institute of Prevention of Occupational Hazards commemorated this date by the organization of a day of study on the basis of the subject held(retained) by the ILO: for safe and healthy workplaces - make some decent work a reality.
- The development of the reserved subject aroused communications of high-quality speakers (professors in occupational medicine, international experts, company doctors, factory inspectors recovering from the ministry of employment, from the employment and from the controllers of the prevention recovering from the Social Security sector, representatives of the UGTA).

- The participation of a population constituted by the members of committees of hygiene and safety and speaker in the field of the prevention of occupational hazards allowed institutions of a rich debate and gave place to an exchange of experiences between experts and administrators of prevention of occupational hazards structures.



- On the occasion of the holding of the world day on the safety and on the health in the work, Madam virot representing the ILO to this event, made the promotion of the agreement 187 relative to the safety and the health at work.
- 350 participants representatives the various social and occupational groups in connection with the domain of the prevention of occupational hazards took part to this day, whom the expected results are a biggest sensitization to the culture of prevention of occupational hazards
